ADDITIONAL AGREEMENT

No. 2 from 20th of January, 2020

to the CONTRACT No. ICB/01/2018_1 from 16th of April, 2019

The given additional agreement is signed, today, 20th of January, 2020

BETWEEN

(1) **1.DAS ÖZEL SAĞLIK HIZ. LTD ŞTİ.**

VE

2.GIZERLER OTO MOTORLU ARAÇLAR A.Ş.

İŞ ORTAKLIĞI and having its principal place of business: Yeni Mh. İncirlik Blv. No:67 Kat:1 No:4, Sariçam/ADANA, **TURKEY (Joint venture)** (hereinafter called “the Supplier”), on one part, AND

(2) **Center for Centralized Public Health Procurement (CCPHP)** of Republic of Moldova, acting for and on behalf of the Ministry of Health, Labour and Social Protection of Republic of Moldova and having its principal place of business at 2/1 Korolenko St., MD-2028, Chişinău, Republic of Moldova (hereinafter called “the Purchaser”), AND

(3) **National Center for PRE-Hospital Emergency Care** of Republic of Moldova, and having its principal place of business at 16 Constantin Vîrnav St., MD-2028, Chişinău, Republic of Moldova, (hereinafter called “the Beneficiary”), on the other part, as modifications to the Contract No. ICB/01/2018_1 from 16th of April, 2019 (named hereinafter Contract).

Any modifications applied for the given additional agreement is mandatory for each part of the Contract, the other unchanged provisions remain mandatory.

By the given additional agreement, in the Contract are introduced the following requirements:

1. the duration of the contract shall be modified. The contract is valid until 31th of December, 2020.

2. the Supplier shall present 2(two) prototypes of ambulances, during 30(thirty)days from request, one ambulance equipped according to the type „B” and one ambulance

equipped according to the type „C” (with medical devices and consumables), for technical evaluation of ambulances by a committee.

The given Additional Agreement is a part of the Contract No. ICB/01/2018_1 from 16th of April, 2019, it shall be deemed to have been concluded on the date of its signature and is fulfilled in 3(three) copies for each part of the Contract.
