



1. INTERVENTION

1.1 Objectives

General objectives:

The main objective of this SPSP (Sector Policy Support Programme, SPSP) is to support Moldova in the implementation of reforms in its drinking water and sanitation sector, by providing finance, technical assistance and policy dialogue for priority activities of high-relevance for the Moldovan population and environment.

Specific objectives:

This Sector Policy Support Programme (SPSP) aims at helping Moldova to achieve the mid-term objectives of the Strategy of water supply and sewage systems in communities of Moldova, approved through Government Decision of 2007 and further updated in 2014. This will be achieved in close co-operation with other international development partners active in the water supply and sanitation sector and, as such, is expected to boost sector reform and donor-government coordination. Notably, results achieved in other projects will be taken into account when assessing the achievement of budget support matrix indicators. The EC-support will be the biggest grant-based support to the Moldovan water sector (drinking- and waste-water/sanitation sub-sectors) in the period 2009-2011. The introduction of EU quality standards will be promoted throughout the programme and demonstrated in a pilot project with a certified EU Member State development agency in the Nisporeni raion of Moldova.

1.2 Expected results and main activities

Expected results

(i) Significant speeding-up of the implementation of the Strategy by supporting the Moldovan authorities in better targeting their interventions and (ii) sustainable improvements in the connection of the Moldovan population to safe drinking water and sanitation infrastructure, in line with relevant EU standards and the country's MDG and National Development Strategy goals in the sector (65% of population connected to safe drinking water and 72% to sanitation systems by the year 2015). The SPSP will also assist in reducing nutrient discharges to the Black Sea basin. Priority investment shall be made to reduce risks to public health e.g. by reducing excessive levels of nitrates and microbial contamination in rural drinking water supplies through fencing of well zones, removal of rubbish heaps, public information campaigns and by protecting groundwater in rural areas, e.g. through simple latrine improvement programmes and/or, improved quality of wastewater discharged to rivers by ensuring primary treatment as an interim measure at locations of future urban wastewater treatment plants,

Activities

Specific activities to be implemented with support of this SPSP shall include inter alia:

- Preparation and implementation of a drinking water protection programme to tackle the most serious water sources pollutions from a health point of view in rural and urban areas of Moldova, especially nitrate pollution in rural wells
- Preparation of a policy document unifying, updating and prioritising the existing 2007 water strategy and 2005 water Programme in terms of costs and timing
- Construction of new or rehabilitated rural water supply infrastructure to provide 55,000 new connections
- Construction of new or rehabilitated rural wastewater infrastructure to provide 25,000 new connections

- Construction of new or rehabilitated urban water supply infrastructure to provide 55,000 new connections
- Construction of new or rehabilitated urban sewer systems to provide 25,000 new connections • Pilot project in Nisporeni raion through indirect centralised management (EU Member-State development agency).
- Targeted TA and training to Moldovan partner institutions that will enable them to speed-up and implement sector reforms, such as sector planning workshops, advice in tariff and investment cost recovery calculations, and on-the-spot trainings in cooperation with professionals from EU countries
- Promulgation of new Water Law and secondary legislation in view of convergence with EU-acquis
- Improved sanitary conditions in 14 rural schools
- Replacement of water supply pumps and associated equipment in 20 pumping stations
- Replacement of wastewater pumps and associated equipment in 14 pumping stations
- Installation of bulk meters at water supply sources in 40 towns
- Provision of leakage detection equipment and training to three regions, North, Central and South
- Public awareness campaign especially in rural areas, concentrating on water-related child health risks.

With respect to project implementation, in response to the Paris Declaration on aid effectiveness and subsequent Accra Conference of September 2008, the Commission developed a strategy for the implementation of recommendations made at these events, with a view to, inter alia, increase Partner Government Ownership (Demand driven approach and/or country managed programmes); enhance Capacity Building with a strong result orientation; enhance donor coordination; increase the quality and make better use of available technical expertise; and avoid the creation of parallel Project Implementation Units.

2 IMPLEMENTATION

2.1 Budget and timetable

The total budget of this operation is €50 million, divided into (i) a €42 million budget support, (ii) a €5 million pilot activity in Nisporeni raion through a certified Member State development agency and (iii) a €3 million technical assistance.

The operational implementation phase will be 84 months, as from the signature of the present Financing Agreement.

Disbursement of budget support instalments will be contingent on Moldova meeting the indicators detailed in the present Financing Agreement.

The indicative amounts and timing of disbursements are summarised in the table below:

2.2 Budget support modalities

The method of management for the programme is centralised, i.e. the budget support operation in itself is managed solely by the Commission.

The budgetary support will be untargeted and as such will be channelled directly into the Unified Treasury Account of the Government of Moldova. Once released, the funds will be used as all other normal budgetary resources of the Government, and managed in compliance with laws and regulations of Moldova.

Foreign-exchange transfers will be entered in the accounts under the value date of the notification of credit to the account of the Central Bank opened for this purpose. The exchange rate will be the middle rate of the interbank foreign currency market on the day of the transfer.

2.3 Performance monitoring and disbursement criteria

With regard to the **performance monitoring arrangements**, oversight of the overall programme will be entrusted to a Steering Committee chaired by the Prime Minister and whose members will include representatives of all ministries and institutions involved in the implementation of the present programme and of representatives of the European Commission.

The members of the Steering Committee are:

- The Prime Minister, Chairman (or appointed representative)
- The Minister of Finance
- The Minister of Environment
- The Minister of Construction and Regional Development
- The General Director of Agency Apele Moldovei
- The President of the Raional Council of Nisporeni raion
- A representative of the association of the mayors of Moldova
- A representative of the association of Moldovan water-works
- The Head of the European Union Delegation to Moldova (or appointed representative)
- A representative of the World Bank office Chisinau (observer)

The Steering Committee will meet at least twice a year to review progress.

To guarantee sound implementation of the Sector Policy Support Programme, the Steering Committee

will ensure that the Government of Moldova fulfils the following commitments throughout the programme implementation period:

1. Associate the European Commission in all Government – donor discussions and institutional arrangements on the elaboration and implementation of the water and sanitation sector reform and Medium Term Expenditure Framework as related to the water and sanitation sector.
2. The Ministry of Finance and all supported ministries and institutions will make available to the European Commission the following documentation related to the implementation of this SPSP:
 - a) Bank statements for the bank accounts referred to in Sections 2.1. and 2.2. of the present Technical and Administrative Provisions.
 - b) Statements of expenditures (Treasury) on sectors relevant to the SPSP.
 - c) Reports on budget planning and execution of the involved bodies (Ministry of Environment; Ministry of Construction and Regional Development; Agency "Apele Moldovei", association of waterworks).
 - d) Laws, Government Decrees, other legislative acts and administrative provisions, draft and final, related to implementation of the SPSP.
 - e) Reports and agreements with the Bretton-Woods institutions, the EIB, EBRD and other international financing institutions in relation to drinking water and waste-water sector reforms and investments.
 - f) Government and other donor policy documents and reports, draft and final, relevant to the implementation of this water SPSP.

Prior to each meeting of the Steering Committee progress reports will be prepared, under the responsibility of the Chairman. Progress reports will describe development in the implementation of the water and sanitation sector reform. They will, in particular show how far the foreseen activities of the Policy Matrix have been implemented.

Information requested to draft the monitoring / progress reports will be collected from the ministries in charge of implementing the reforms.

If considered appropriate, and until a functional monitoring mechanism satisfying the requirements of the programme is in place, the European Commission might mandate consultants to carry out an independent review of some or all disbursement indicators. As soon as the Government will have put in place a monitoring mechanism of the water and sanitation sector acceptable to the Commission, the possible unused balance of funds allocated to technical assistance may be transferred to the budget support component of the programme and increase in a proportional manner the amounts of the remaining instalments, so as to increase the disbursements proportionally, if the related indicators are met.

The release of the foreign exchange under the programme is contingent on **the following general conditions**, applying to all tranches, being met:

1. Satisfactory progress in the implementation by the Government of Moldova of a sector policy and strategy and continued credibility and relevance of that or any successor strategy
2. Maintenance of a credible and relevant stability-oriented macroeconomic policy or progress made towards restoring key balances.

3. Satisfactory progress in the implementation of the Government programme to improve public financial management.
4. Satisfactory progress with regard to the public availability of accessible, timely, comprehensive, and sound budgetary information.

Specific disbursement conditions will apply in the following areas, which are actually five Mid-term objectives from the Existing "Strategy of Water Supply and Sewage Disposal in Communities of Moldova":

1. Extension of centralised water supply and sewage systems and increase of degree of access for population to these services
2. Decentralisation of public water supply and sewage services in Moldova
3. Promotion of market economy principles
4. Promotion of sustainable development and environment protection measures
5. Promotion of social partnership

More detailed information on the specific conditions, including on the indicators to be used to measure their degree of fulfilment, are given in appendices 1, 2 and 3.

The chosen performance targets and indicators specified in Appendix 1 will apply for the duration of the SPSP. However, in exceptional, duly justified circumstances, the Chairman of the Steering Committee may submit a request to the European Commission for the targets and indicators to be changed (including possible modification or inclusion of specific health sector performance indicators). The agreement on the changes to the targets and indicators shall be formalised through an addendum to the present Financing Agreement, in accordance with the provisions of the General Conditions (in particular article 17).

In order to assess the progress of reforms supported by the Sector Policy Support Programme, the Commission will avail itself of the assessment made by its own staff, and need be, of external technical expertise.

In view of minimising transaction costs for the Government, the following review mechanisms will be utilised to review the several general and special conditions and serve as a basis for assessing progress and performance of the Sector Policy Support Programme:

Reports by the Government and Reviews by the IMF, the World Bank and the EU will serve as a basis for assessing the macroeconomic stability framework eligibility criterion. Commitment of the Government to implement the EU-Moldova Action Plan and its successor documents will be assessed on the basis of the Action Plan implementation reports produced by the European Commission with cooperation of the Government and of other interested organisations. Government progress reports and PFM-related Reviews of the EU, the World Bank and the IMF will serve as a basis to assess the progress and the performance in some areas of PFM, and water and sanitation reform.

Schedule of reviews of this SPSP

To all possible extent, the schedule of reviews will be coordinated with other donors involved in sector budget support operations.

Subsequent disbursements will be conditional to the achievement of the targets related to the indicators included in these Technical and Administrative Provisions and refer to activities listed above under paragraph 1.2.

2.4 Procurement and financial procedures

The following provisions apply only for complementary support such as TA, audit, evaluation:

Procurement procedures

All contracts implementing the action must be awarded and implemented in accordance with the general and specific conditions of the Financing Agreement and with the procedures and standard documents drawn up and published by the Commission for the implementation of external operations in force at the time of the launch of the procedure in question.

Payments

All payments must be made by the Commission in accordance with the general and specific conditions of the Financing Agreement and with the procedures and standard documents drawn up and published by the Commission for the implementation of external operations in force at the time of the launch of the procedure in question.

3. EVALUATION AND AUDIT

The programme will be subject to independent reviews that will assess the level of compliance / performance with its conditions / indicators set forth in the present Financing Agreement.

In the event of failure to fulfil a condition or achieve a quantitative target or indicator due to *force majeure* it will be possible for the given condition or indicator to be neutralised as a determinant of the variable instalment.

The European Commission might mandate consultants to carry out, in close cooperation with the Court of Accounts of Moldova, an audit of a sample of expenditures related to the implementation of the selected water and sanitation development strategy activities.

Prior to completion of the SPSP, the European Commission will mandate consultants to carry out an independent final evaluation of the programme.

4. COMMUNICATION AND VISIBILITY

The Government shall ensure that the visibility of the European Commission contribution to the programme is at least equivalent to that given through media to other donors supporting the implementation of the Government of Moldova reforms in the area of PFM, and water supply and sanitation.

Appendix 1: Performance indicators used for disbursements

Review of Policy Matrix implementation results should be considered the basis of assessment of programme success.
